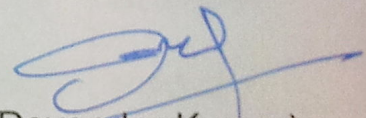
Subject: Constitution of Implementation and Monitoring Committee for MOOCs Content

An "Implementation and Monitoring Committee for MOOCs Content" given below is being constituted to implement and monitor the design/repurposing of existing digital content (CBSE, CEC, NPTEL, UGC etc.) and creation & delivery of new content henceforth. It shall be responsible for the coordination of the delivery of MOOCs, identification of subject experts in all disciplines of study for delivery of MOOCs, recording of content, conduct of proctored online examinations and award of certification with appropriate credits, delivery and scaling up of Indian MOOCs services through Cloud services on a self sustained basis:-

The Terms of Reference of the Committee shall be as follows:

1. The Committee shall be responsible for identification, design, development, repurposing and operations of Indian MOOCs projects on a continuous basis, etc., as indicated above.
2. Identification of subject experts for all courses in all disciplines including Medical, Engineering, Humanities, Vocational, Law, Agriculture etc. and assignment of subjects as per the individual specializations towards the design of Indian MOOCs in a sustained manner.
3. Fixation of milestones for continued deliverables of the project and their monitoring.
4. To suggest models for self sustenance of Indian MOOCs.
5. To suggest initiatives towards Public Private Participation for Indian MOOCs.
6. Project monitoring at regular intervals, peer-review meetings for authentication of content, monitoring of progress and dovetailing with other projects in the same broad areas of activity.
7. The Committee shall meet at least once in a month or earlier as needed at the venue convenient to the Chairman and to majority of the members of the committee.
8. The Mission Secretariat of NMEICT shall prepare the minutes and are required to be approved by the committee on the same day.
9. The committee may co-opt other members as deemed necessary and also form sub-committees as desired by it from time to time with specific terms and conditions.
10. The TA/DA and honorarium as applicable payable to all the outside participants attending the Committee meetings and shall be borne out of NMEICT Mission Secretariat's Funds.
